# IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

#### A COUNCIL BILL

TO APPROVE the Demolition of the Food Distribution Center in Poteau, Oklahoma.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Tribal Council of the Nation (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

WHEREAS, the Nation will be constructing a new Community Center (the "New Community Center") in Poteau, Oklahoma, on the real property where the Nation currently has a Food Distribution Center (the "Food Distribution Center") that it no longer uses;

WHEREAS, the Food Distribution Center must be demolished to make way for the New Community Center; and

WHEREAS, the Council has determined that it is in the best interests of the Nation to demolish the Food Distribution Center.

**THEREFORE BE IT ENACTED** by the Council that this Bill be cited as approval for the demolition of the Food Distribution Center.
