#### RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

#### A COUNCIL BILL

TO APPROVE application for FY25 Community Services Block Grant funding from the Department of Health & Human Services.

WHEREAS, the United States Department of Health & Human Services is accepting applications for FY25 Community Services Block Grant funding. This grant provides a range of services to address the needs of low-income individuals to improve the causes and conditions of poverty, and to impact causes and conditions that result in people being inadequately employed, educated or housed, or needing help to make best use of their resources;

WHEREAS, the Choctaw Nation of Oklahoma (the "Nation") desires to coordinate and establish linkages between governmental and other social service programs to assure effective delivery of such services by conducting activities designed to assist low-income participants with benefits to supplement and support services provided by other tribal programs, or to provide services which might otherwise not be available through any other agency or source;

WHEREAS, the Nation will use the funds to assist low-income participants with home energy related costs; and

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma finds it is in the best interest of the Nation to approve the application for FY25 Community Services Block Grant funds from the United States Department of Health & Human Services.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the application for FY25 Community Services Block Grant funds from the United States Department of Health & Human Services to provide assistance with home energy related costs to eligible participants.

**BE IT FURTHER ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
