# IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION JENNIFER WOODS INTRODUCED THE FOLLOWING COUNCIL RESOLUTION

#### A COUNCIL RESOLUTION

**TO APPROVE** naming the new Forestry building located in Talihina, Oklahoma the Shane Sparks Forestry Building.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma, "The Tribal Council shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property";

WHEREAS, the late Shane Sparks was a proud and loyal Choctaw Tribal Member and a vital member of the community. Shane Sparks worked for both the Agriculture Department in the Indian Lease Lands and the Choctaw Nation Forestry Department out of Talihina;

WHEREAS, Shane Sparks is deserving of the recognition and distinction of having the new Forestry building located in Talihina, Oklahoma named in his honor for his service and dedication as an employee of the Choctaw Nation Forestry Department and for being a true asset to all;

WHEREAS, in appreciation and acknowledgement of Mr. Sparks' dedication and service, the Tribal Council (the "Council") of the Choctaw Nation of Oklahoma (the "Nation") has received a petition containing the signatures of seventy-five (75) individuals supporting the naming of the new Forestry building located in Talihina, Oklahoma as the Shane Sparks Forestry Building (See Exhibit A attached); and

WHEREAS, the Council has determined that it is in the best interests of the Nation to name the new Forestry building located in Talihina, Oklahoma *the Shane Sparks Forestry Building* to show appreciation and pride in those who go beyond the call and serve the Choctaw Nation Agriculture Department, Forestry Department and the community, as Shane Sparks did for many years.

**THEREFORE BE IT RESOLVED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval for naming the new Forestry building located in Talihina, Oklahoma *the Shane Sparks Forestry Building* and the building shall have its new name affixed above the entrance.

**BE IT FURTHER RESOLVED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
