RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL RESOLUTION

A COUNCIL RESOLUTION

TO APPROVE a limited waiver of sovereign immunity in favor of SA American Dream Vactions LLC.

WHEREAS, in accordance with Article IX, Section 4 of the Constitution of the Choctaw Nation of Oklahoma, "The Tribal Council shall enact legislation, rules and regulations not inconsistent with this Constitution for the general good of the Choctaw Nation and for the administration and regulation of the affairs of the Choctaw Nation";

WHEREAS, the Tribal Council (the "Council") of the Choctaw Nation of Oklahoma (the "Nation") has determined it is in the best interests of the Nation to provide motor homes for employees of the Nation who work at the annual Choctaw Nation Labor Day Festival (the "Festival");

WHEREAS, SA American Dream Vacations LLC, a Texas Limited Liability Company ("American Dreams"), has been selected as the provider of motor homes for the Festival;

WHEREAS, the Nation has negotiated an agreement with American Dreams (the "American Dreams Agreement") setting forth the terms and conditions under which American Dreams will provide motor homes to the Nation for the Festival;

WHEREAS, the American Dreams Agreement contains a limited waiver of sovereign immunity from suit in favor of American Dreams and as limited under the terms of the Agreement; and

WHEREAS, the Tribal Council has determined that it is in the best interest of the Nation to grant such a limited waiver of sovereign immunity in favor of American Dreams solely to the extent of, and in accordance with, the terms of the American Dreams Agreement.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Council Resolution be cited as approval and authority for the grant of a limited waiver of the sovereign immunity of the Nation in favor of SA American Dream Vacations, LLC, and in accordance with the terms of the agreement between the Choctaw Nation of Oklahoma and SA American Dream Vacations, LLC.

BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Council Resolution be cited as approval and authority that nothing contained herein is intended to, nor shall it be construed to, benefit any party other than SA American Dream Vacation, LLC.

BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Council Resolution be cited as approval and authority that nothing contained herein is intended to, nor shall it be construed to, waive the sovereign immunity of the Nation or any of its affiliates or subsidiaries except as specifically set forth herein.

BE IT FURTHER ENACTED, by the Tribal Council of the Choctaw Nation of Oklahoma that this Council Resolution be cited as approval and authority that nothing contained herein is intended to, nor shall it be construed to, waive the sovereign immunity of any elected official, officer, or employee of the Nation or any of its affiliates or subsidiaries, and no waiver of immunity is provided with respect to such parties.
