How to earn entries:

- Choctaw Nation Tribal Members can visit choctawnation.com to enter to win \$2,500 in cash after the State of the Nation during the entry dates of 10 a.m. September 2, 2024, through 11:59 p.m. September 15, 2024. Submissions will be completed by the following method: webform online.
- The drawing will be held on September 16, 2024, and the winner will be contacted after verified.
- The communications team will randomly draw and select a winner.
- Prize must be claimed within 24 hours, or the prize will be forfeited, and a new winner will be selected.
- Winners are limited to one person per drawing;
- The winner will receive a prize of \$2,500.
- Winners will be contacted via the phone number and email listed on webform immediately following the verified Tribal Member eligibility for the drawing.
