# TO APPROVE THE CHOCTAW NATION FORESTRY DEPARTMENT TO CONDUCT TIMBER SALES ON CHOCTAW NATION OF OKLAHOMA OWNED LANDS

#### IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

#### RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL RESOLUTION

#### A COUNCIL RESOLUTION

**TO APPROVE** the Choctaw Nation of Oklahoma Forestry Department to conduct timber sales on Choctaw Nation of Oklahoma (the "Nation") owned lands for the period October 1, 2024 to September 30, 2029.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma: "The Choctaw Tribal Council shall make decisions pertaining to the acquisition, leasing, disposition and management of tribal property";

WHEREAS, the Choctaw Nation Forestry Department (the "Department") manages the Nation's forest lands and timber resources and wishes to conduct strategic timber harvesting to promote overall forest health and resilience;

WHEREAS, the Department wishes to conduct timber sales in order to ensure sustainable forest management practices and to maintain and enhance forest ecosystems, addressing and mitigating the impacts of insect infestations and diseases that threaten forest health, and generate revenue to support the economic development of the Nation;

WHEREAS, the Department proposes that the total value of each timber sale does not exceed \$500,000.00 during the five year period from October 1, 2024 to September 30, 2029. This limit will ensure that operations remain within manageable and sustainable limits to align with the Nation's long-term goals and values;

WHEREAS, in order to conduct timber sales from tribal lands in compliance with Title 25, Section 163.14 of the Code of Federal Regulations, Tribal Council approval is required;

WHEREAS, the Department will conduct timber harvests and sales in a manner that respects the environment, upholds the highest standards of sustainability, aligns with the cultural values and traditions of the Nation, and complies with all Choctaw Nation of Oklahoma law and policy and applicable federal law and regulations; and

WHEREAS, the Tribal Council has determined it is in the best interest of the Nation to approve the sale of timber from Choctaw Nation of Oklahoma lands in accordance with the foregoing requirements and principles and the requirements of Choctaw Nation of Oklahoma law and policy and federal law and regulations.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval for the Choctaw Nation Forestry Department to conduct timber sales on land owned by the Choctaw Nation of Oklahoma for the period October 1, 2024 to September 30, 2029.

**BE IT FURTHER ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval for the total value of each timber sale to not exceed \$500,000.00 during the five-year period from October 1, 2024 to September 30, 2029.
