

TO APPROVE AGRICULTURAL LEASE NO. 4200460058 (G09-2094) IN FAVOR OF MR. FRED JAMES, JR., ON LAND HELD BY THE USA IN TRUST FOR THE CHOCTAW NATION IN LATIMER COUNTY, OKLAHOMA

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION
RONALD PERRY INTRODUCED THE FOLLOWING BILL**

A COUNCIL BILL

TO APPROVE Agricultural Lease G09-2094, in favor of Mr. Fred James, Jr., on land held by the USA in Trust for the Choctaw Nation in Latimer County, Oklahoma.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation (“the Nation”), the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation;

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation, The Tribal Council (“the Council”) shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property.

WHEREAS, Mr. Fred James, Jr. has proposed an Agricultural Lease on property held by the USA in Trust for the Choctaw Nation located in Section 15, Township 4 North, Range 18 East, Latimer County, Oklahoma, containing 160 acres, more or less. Please see the attached Lease labeled Exhibit A, aerial map labeled Exhibit B, and location map labeled Exhibit C.

WHEREAS, the payment will be \$3,010.00 per year. In addition to the rental payments, Mr. Fred James, Jr. has agreed to practice weed, sprout, and brush control on 75 acres of open land each year.

WHEREAS, the lease shall be for a Three (3) year term beginning on January 1, 2025,

WHEREAS, this lease or any modifications or amendments to this lease are not valid or binding unless approved by the U.S. Secretary of Interior or an authorized representative acting under delegated powers.

THEREFORE, BE IT ENACTED by the Tribal Council that this Bill be cited as approval of the proposed Agricultural Lease No. G09-2094, located in Section 15, Township 4 North, Range 18 East, Latimer County, Oklahoma, in favor of Mr. Fred James, Jr., on land held by the USA in Trust for the Choctaw Nation. 
BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation that this bill be cited for approval of the payment of \$3,010.00 for a three (3) year term, beginning on January 1, 2025.

BE IT FURTHER ENACTED by the Tribal Council that this Bill be cited as an acknowledgment that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver, and file any all agreements, certificates, instruments, and documents in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve and take such other action as he, she, or they may deem proper or appropriate to carry out the intent and purposes of the foregoing enactments.



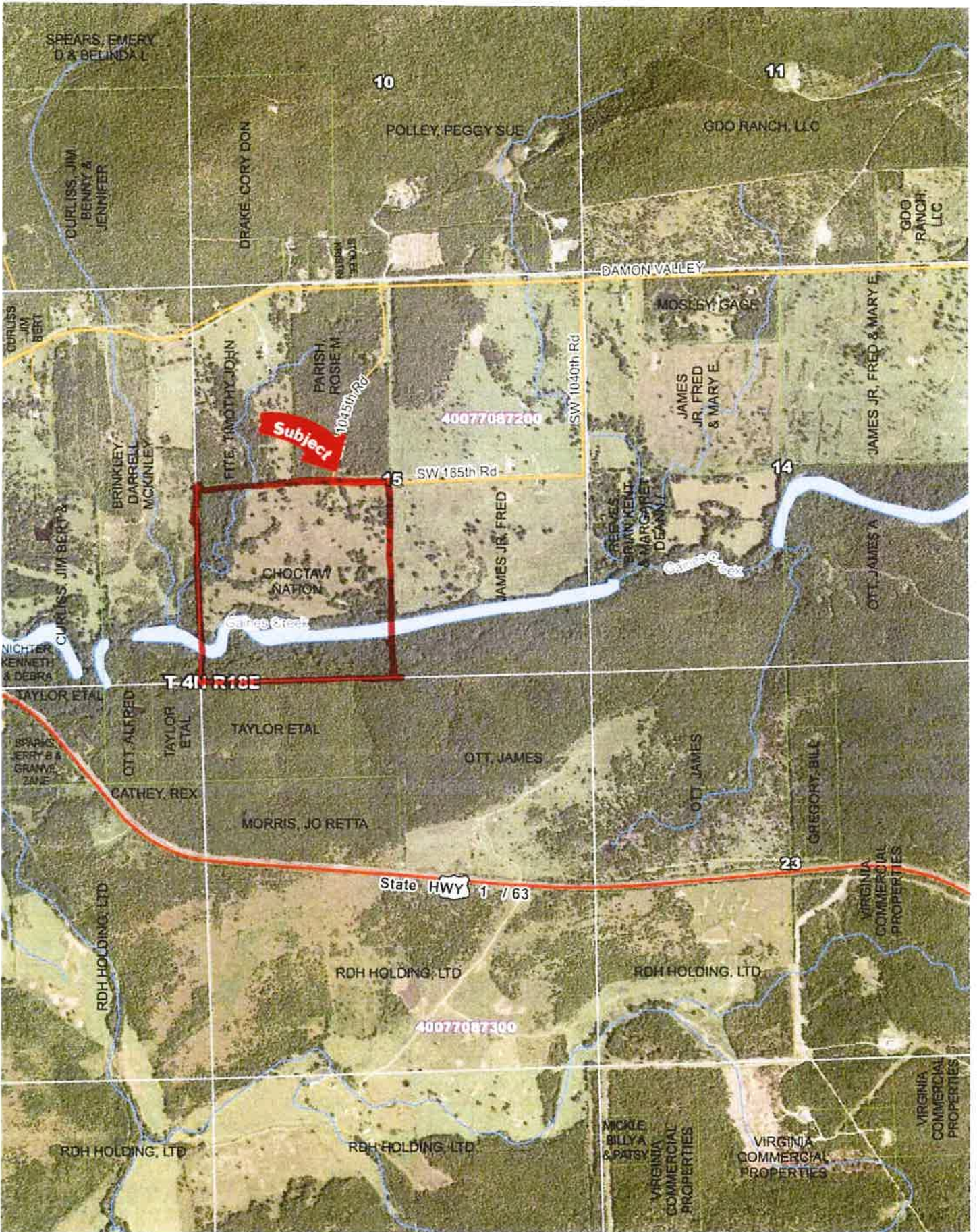
AGRICULTURAL LEASE

THIS CONTRACT, made and entered into on **August 23, 2024**, by and between the Indian or Indians named below (the Secretary of the Interior acting for and on behalf of the Indians), hereinafter called the "Lessor", and **Fred James, Jr., 611 SW 10th Street, Wilburton, Oklahoma 74578**, hereinafter called the "Lessee", in accordance with the provisions of existing law and regulations (25 CFR 162) which, by reference, are made a part hereof, WITNESSETH, that for and in consideration of the rents, covenants and agreements hereinafter provided, the Lessor hereby lets and leases unto the Lessee for **GRAZING** purposes only, the following described property:

SW ¼ of Section 15, Township 4 North, Range 18 East, Latimer County, Oklahoma, containing 160 acres; more or less.

of which not to exceed -0- acres may be cultivated, for a term of **Three (3) years**, beginning on **January 1, 2025**, and expiring on **December 31, 2027**, subject to the conditions hereafter set forth. 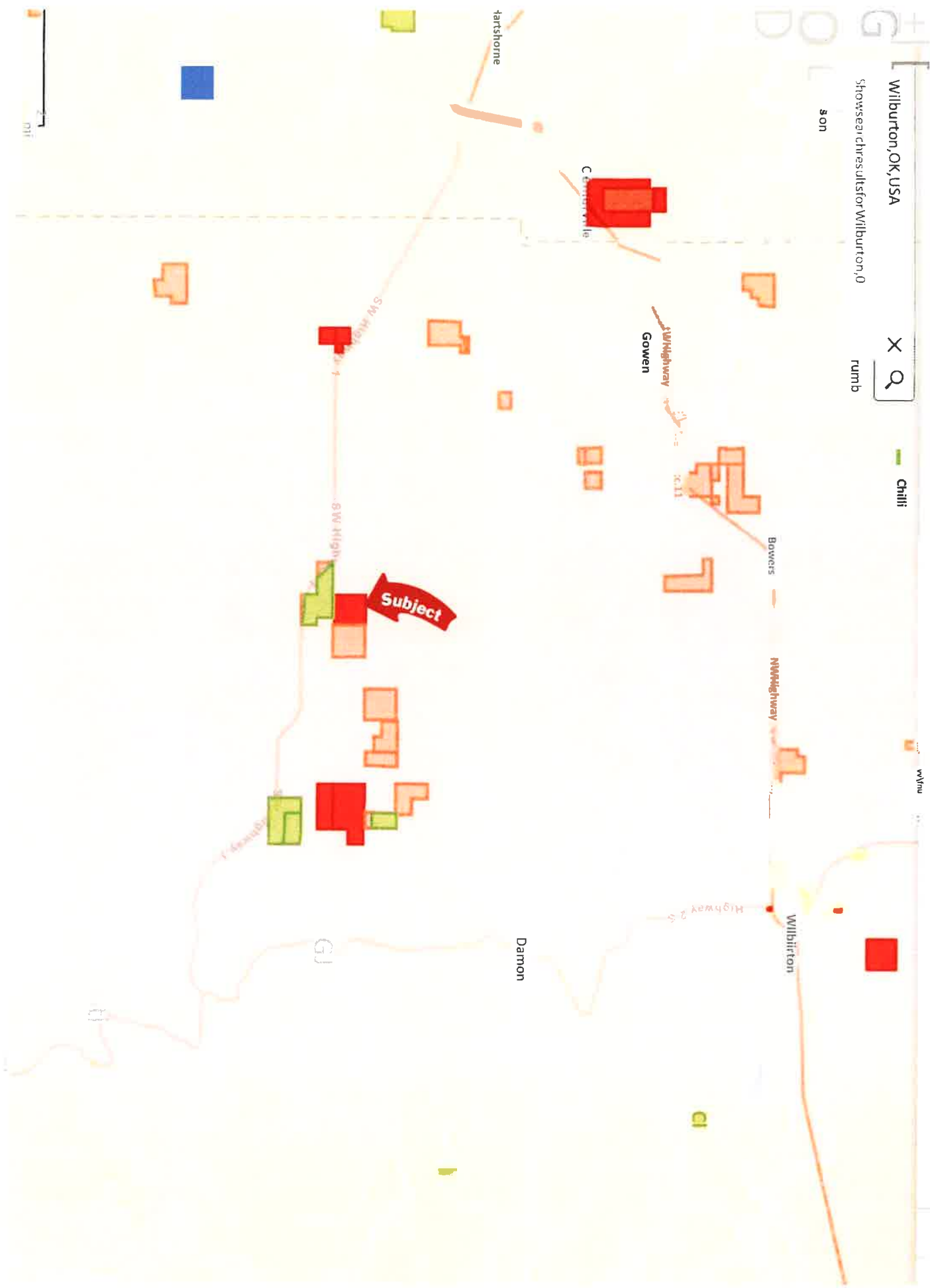
