WHEREAS, the National Institutes of Health seeks nominations and reappointments to their Tribal Advisory Committee;

WHEREAS, in accordance with Article VII, Section 2 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Chief has the power to "establish and appoint committees, members and delegates to represent the Choctaw Nation with the advice and consent of the Tribal Council.":

WHEREAS, Chief Gary Batton nominates Todd Hallmark, Choctaw Nation Executive Officer of Health, to serve on the NIH TAC as the Oklahoma Area Alternate to represent the Nation, our Choctaw Nation Health Services Authority, and Choctaw tribal members and other Native Americans served through Nation's healthcare system;

WHEREAS, Mr. Hallmark's education, experience, expertise, as well as his commitment to serving the Nation and its people through excellence in healthcare provision make him a great fit for this role;

WHEREAS, the Tribal Council of the Nation supports efforts to build and grow our relationship with the National Institutes of Health and the medical community across the United States and Indian Country;

WHEREAS, Mr. Hallmark is highly qualified and equipped to serve on this committee due to his commitment to serving our tribal members. Mr. Hallmark has grown the Choctaw Nation Healthcare Services Authority to include CMS Five-Star rated acute care hospital, 9 ambulatory clinics, 16 wellness centers, and serving 40,000+ Native Americans annually; and

WHEREAS, the Tribal Council has determined it is in the best interest of the Nation to support the nomination of Todd Hallmark to serve on the National Institutes of Health (NIH) Tribal Advisory Committee (TAC) as the Oklahoma Area Alternate as a representative of the Nation.

THEREFORE, BE IT RESOLVED by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval for supporting the nomination of Todd Hallmark to serve on the National Institutes of Health (NIH) Tribal Advisory Committee (TAC) as the Oklahoma Area Alternate.
